Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, at about 1:00 AM on 22nd August 2023, a huge contingent of armed Meetei/Meitei radicals, suspected to be member of the Arambai Tengol and Meeitei Leepun along with a mob numbering around 1000 attacked our locality with supplicated weapons, so in order to save our lives our family have to run and leave behind our house along with all our household items and properties on May 4th night 2023.
2. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be around Rs.40,00,000/- (rupees Forty Lakhs) only.




