Subject: Report on destruction of poppy plantation at Monglham village, under Thoubal Dam Police Station.

Sir

This is to inform you that as per the Orders of the Superintendent of Police, Kamjong District vide No. 1-B/17/(ND&PS)/SP(KJG)/9756 Dated 21/11/2023, a joint team of Kamjong district Police, District Administration, Kamjong, MR personnel, personnel from NAB, Forest Department and 24 AR personnel conducted an extensive poppy destruction drive at the hill ranges of Bohoram village and Itham village w.e.f 28/11/2023 to 30/11/2023 and successfully destroyed 15 Acres of Poppy plantations at Itham village and another 15 Acres at Bohoram village which are under Kasom Khullen Police Station. During the drive, extensive poppy cultivation was observed at the hill range of Monglham (Kuki) village which is adjacent to Bohoram village. Monglham village itself falls under your functional jurisdiction. However, in good faith and in view of the prevailing serious law and order issue that exhibits threat to the security personnel in travelling to places of Kuki inhabited areas coupled with the plantation of poppy itself being a cognizable offence, the joint team noted above extended the poppy destruction drive at the hill range of Monglham village. Subsequently, 40 Acres (Approx) of poppy plantation at Monglham village was destroyed. The destructed areas being within your functional jurisdiction, official information is hereby given for taking further legal action from your end.
