I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a resident of House No. 1, Haokip Veng Palace Compound, P.O. & P.S.- Porompat, district- Imphal East, Manipur.

That, on the 4th of May, 2023 at around 12:30 PM, a mob of armed Meitei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with the locals in and around the area attacked our village, in the process they have looted and vandalized my rented house owned by @Lunkhongam Touthang(9612248477) along with all the properties / household items.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.40,00,000 (*Rupees Forty Lakhs*) Only, inclusive of my properties along with my two vehicles, such as;

- 1) Bajaj Auto RE 2 Stroke bearing regn. No. MN06 S 5458.
- 2) Maruti Omni Van bearing regn. No. MN01 G 6972.

That, the reason behind my late application is due to which I was at different states / remote areas for months.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.





With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, I would like to inform that I had been allotted my permanent resident at 3rd Street, New Lambulane, Imphal East, PS – Porompat. That, due to the communal clash that broke out from 3rd May, 2023, we had abandoned our residential home for our safety and get evacuated to a safer place.

However, on 5th May, 2023, we had received information from our neighbours that on the same day at around 6:00 p.m, my residential home was broke opened by unknown miscreants and my residential semi pucca and household properties worth Rs. 56,00000/- were looted/stolen away by the said miscreants.

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreant and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement and lack of legal knowledge.
