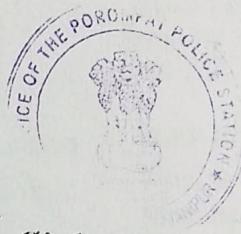
Sir,

I have the honour to report that due to communal violence in between Kukis and Meiteis communities on the 4th January, 2024 at around 9:30.pm some unknown miscreants suspected to be Meitei community Arambai Tenggol, Meitei Leepun wearing Police and Commando uniforms forcefully attacked my commercial residential house (JE Collection) located at New Lambulane 3rd Street, PO & PS- Porompat, Imphal East District.

As a result, they destroyed and looted all my valuable household properties including some important documents. The lost properties are approximately worth as Rs. 4.5 Crores only. Due to displace of all my family, I could not report in time.

I, therefore, humbly request you to kindly take up necessary legal action as per law of the land.




