Sir,

I have the honour to report that on 16/01/2024 at about 09:45 pm., one unknown driver of four wheeler Ambulance bearing registration no. not known coming from west to east at Lamlong Bazar knocked down one Activa 125 silver colour bearing regd. No. nil driven by my cousin brother namely Md. Tajmir aged about 23 yrs. s/o Md. Abdul Hakim of Uchiwa Nastao coming in opposite direction at Lamlong Bazar near Traffic island due to rash and negligent driving on the part of unknown Ambulance driver. However the said Ambulance escaped from the spot on taking advantage of the darkness without any cooperation. As a result of which, Md. Tajmir received serious injury on his body parts and giving medical treatment at JNIMS, Porompat for medical treatment and also badly damaged the said Activa 125.

It is, therefore, requested to kindly take up necessary legal action against the culprit as per provision of law.
