Subject: FIR report on stolen vehicle.

Sir,

With due respect, I the undersigned, NONGTHOMBAM SURANGINI DEVI (TGT Social Science), posted in Jawahar Navodaya Vidyalaya Churachandpur since October 2013 aged about 49 years and a resident of Nongmeibung Porompat, Imphal East would like to submit the following few points for your kind consideration and favourable necessary actions.

1) On 3/5/2023 due to the fear of our lives, my family members fled at the campus of 36 AR situated at the H/Q Veng, Ccpur because of the violence erupted between the Meitei and the Kuki community at the unworldly time of 12 o'clock midnight of the said day.

2) Later, I have been informed that my official quarter allotted to me had also been ransacked and looted all my valuable belongings by the unruly mobs in the said clash between the two communities.

On 8/05/2023, while me and my family members were taking shelter in the campus of the 36 AVR H.Q my

kept inside my garage was taken away by the said unruly mobs.

3) Later, on 13/05/2023 again my **HONDA ACTIVA 5g (2-wheeler)**

Registration no: MN 01AE 9812

Colour-Red has also been taken

away by unknown miscreants taking advantage of the unruly mob.

In the light of the aforesaid facts and circumstances, I would like to lodge an

FIR against the miscreants and kindly request you to arrest the parties involved in the act as soon as possible in the interest of justice.
