Sir,

I, the undersigned, would like to submit a report for your kind consideration and request necessary legal actions.

Despite the Protection Order issued by the Ld. Chief Judicial Magistrate, Imphal East, in the Criminal Misc. Case No. 11 of 2023 on 25/01/2023, arising out of Criminal (D.V.) Case No. 5 of 2023, my father, namely, Senjam Prithiviraj, has been assaulting my mother, namely, Ngangom Premabati Devi, causing grievous physical and mental harm since yesterday's night because of a trivial issue. Such acts have outraged the modesty of my mother, and it appears that my father has violated the court order.

Furthermore, my father also assaulted me and my sister, namely, Ankita Senjam and threatened to kill my mother, me and my little sister. Such acts have put us into a difficult and life threatening situation.

Therefore, I kindly request your intervention in this matter and urge you to take necessary legal actions at the earliest.

Thank you for your prompt attention to this serious issue.




