



Sir,

I have the honour to report that on 03/06/2023 at about 9:00 pm unruly mobs miscreant suspected to be of Kuki community numbering about 50/60 carrying with deadly substances attacked Serou Awang Leikai, Kakching District, Manipur. In the incident, the miscreants vandalized all my households' properties and looted all valuable items and later burnt the house to ashes.

The approximate value of loss/destroyed and looted properties is estimated to be about Rs. 25 lacs

It is therefore, requested kindly take up necessary legal action against them according to law.




