

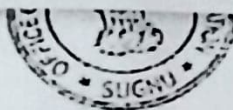

Subject: Request for lodging of FIR case regarding looting & ransacking/burnt down of my house/grocery shop located at Serou Awang Leikai on 28th May, 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meltei inhabited areas of Serou Town on 28<sup>th</sup> day of May 2023 at around 2.30am. The said unidentified groups vandalised/burnt down my house/grocery shop and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs 65 lakh (Rupees sixty five lakh). After the said unfortunate incident/mob violent, my family are fleeing our village and my family is taking shelter at a relief camp at Ema Laikhutlembi Laibung, organised by Eastern Educational Club (EEC) situated at Khurai Ahongel leikai, Imphal East District, Manipur.

It is, therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action(s).
