With due respect and humble submission, I beg to state that on 05/01/2024 at around 08.00 Pm, some unknown armed miscreants suspected to be Arambai Tenggol and Meitei Leepun destroyed/looted all my valuable household properties including some important documents, CGI Tin Sheets 920(Nine hundred twenty pieces), 1(One) Four wheelers (Honda CRV) bearing Regn. No. MN05A-4751 and later burnt down my residential Pucca house(four storey) and One wooden house with Patta number 26(A) 294 which is located at New Lambulane (between 2nd & 3rd Street) which falls under the jurisdiction of Porompat Police Station, Imphal East. The estimated value of the properties looted/destroyed/burnt down is around Rs. 12(Twelve) crores only.

Therefore, I request you to kindly register the case and take necessary action as per the law of the land.




