Dear Sir,

With due respect, I would like to inform you that on 5<sup>th</sup> January 2024, suspected  
Meitei people have broken down the door of my abandoned house and looted all my  
valuable belonging that cost an amount of Rs. 25,00,000/- (Twenty Five Lakhs  
rupees) from my house where I stay there as a tenant while the landlord is  
Mr. Henjakhup Vaiphei. Everything is looted and stolen from my house, which is  
located at Mr. Henjakhup Vaiphei residence, 3<sup>rd</sup> Street, New Lambulane, Imphal,  
Manipur. Landmark-Near MPCs Church. I was compelled to lest my house on 4<sup>th</sup>  
May 2023 due to ethnic war between the Meitei and KUKI.

Therefore, I request you to look into the matter and file the F.I.R at your Police  
Station for further necessary actions that needed to be taken.

The incident could not be reported immediately due to Medical trearment and  
insecurity of our live and volatile situation of the area.




