With due regards, I am to state that I have left my residence at New Lambulane First Street on 6<sup>th</sup> May, 2023 due to the ethnic violence that erupted on 3<sup>rd</sup> May, 2023.

That, I have learnt from a reliable source that my house has been ransacked and looted by unknown persons from my residence at New Lambulane, First Street during the month of December, 2023.




