

Sir,

I have the honour to report that on 28/05/2023 at about 2:35 am unruly mobs miscreant suspected to be Kuki community numbering about 50/60 carrying with deadly substances attacked Sugnu Awang Leikai, ward No. 1 Kakching District, Manipur. In the incident, the miscreants had partially vandalized all my households' properties and looted some valuable items and later partially burnt the houses.

The approximate value of loss/destroyed and looted properties is estimated to be about Rs. 1.51 cr.

It is therefore, requested kindly take up necessary legal action against them according to law.
