



Today i.e., 22/01/2024 at about 1:30 pm, learnt from Facebook user Korounganba Khuman post on 18/01/2024 stating that "All AT unit 1 to 55 camp singda lina sem saduna leigadabani. Lakliba date 24 Leibak sigi Meitei MLA MP Minister opposition ruling linaamak amadi hon'ble CM yaona kangla utra mamangda famlaga ereibak efurup ki aroiba warep loughani. Masida Delhi da lei aduda lei hyba amata yaro lei lak kadabani.. Masida lak taba sing Meitei ni khalaroi Mareibak mafurup ki yeknabani loughani aduga AT karino khanghan gani. Masida afa fatta nasana pugadabani. Eikhoina MLA Minister MP oina Khalaga houba nate Meitei amani khalaga koubani." The literary meaning translated as "All AT (Arambai Tengol) Unit 1 to 55 to be readily stationed at camp. On the coming 24 day of January, 2024, all Meitei MLA, MP, Ministers of both ruling and opposition including Hon'ble CM must come at Kangla Utra and take final decision of the Meitei community. No one cannot deny by stating that he is at Delhi or somewhere. If any MLA, MP, Minister do not come on the said day, he/she will be treated as enemy of the Meitei community and AT will teach them what is AT and consequences will be face by themselves. They are not calling as MLA/MP/Minister but as a Meitei. The act of the said Korounganba of Arambai Tengol amount to threatening to all Meitei MLA /MP/Minister by a gang party.

Hence, a suo-motto under FIR No. 58(1)2024 PRT-PS u/s 400/506 IPC is registered against the leader of Arambai Tengol namely Korounganba for investigation.
