



With due respect and regard I would like to inform you that I along with my family have fled and left my resident i.e. 39 Newlambulane Imphal East P.S Porompat on 6 may 2023 due to the ethnic violence that erupted in the state to save our lives. It has come to my knowledge that on 21 Nov 2023 some miscreant have entered my house and looted my property worth Rs 26 lakh including beds almerah, arm benches, chair, gas cylinder, refrigerator, washing machine, television, tv stand, dining table, blanket, gold ornaments , kitchen items, electronic gadgets, clothing and one scooty active 125 cc etc.

I therefore request you to registered an FIR against the culprits and take up necessary legal action regarding the incident
