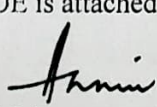

Subject: Report for taking necessary legal action

Sir,

I am to report that due to the conflict erupted between the Meiteis and Kukis on 3rd May, 2023 and the Meiteis attacked the Kukis at different locations within Imphal especially, our locality New Lambulane, our family and Kuki neighbours are compelled to flee for our lives. Our family is forced to abandon our dwelling house at New Lambulane 1st Street, opposite VBCA church, Imphal East district only with our wearing apparel and light bedding. I along with family took shelter at Lyolapati for the night of 04-05-23 and then evacuated to CRPF camp Lamphel on 05-05-23 on 07-05-23 we were again transported to Kangpokpi via Mokbung and stayed at Kangpokpi till date.

Since our departure from New Lambulane, there is no chance of going back and enquire our properties and dwelling house. No information is received regarding the commission of Theft and burglary for the last five or six months in our left behind dwelling house comprising a four room house and another separate room for my daughter study room equipped with full family necessary materials. It is also to state that the housing complex is owned by Mr. Lijam Amo and we stayed on rent.
