



Subject: Report for taking necessary legal action

Sir,

I am to report that our local church is place of worship 'Imphal Revival Church of God' located at New Lambulane, 3rd Street is conducting our church services smoothly till April, 2023. The house belongs to one Smt Nemjarai and two rooms on the ground floor is occupied by our church committee on rent more than ten years back. I am serving as the secretary of the church since the last five years till date.

As no Kuki - tribe is allowed to stay back in the valley districts of Manipal due to the conflict since 3rd May, 2023, the church was left unattended. No information regarding the commission of theft and looting is received during the last five or six months.

But recently during the first week of January, 2024 received a reliable information that the lock is broken and vandalised the church by suspected Meitei individuals or group and some moveable properties stolen.

It is therefore requested that necessary legal action may kindly be taken to apprehend the culprits involved in the vandalism of our church & place of work and book them according to law & justice.
