With due regard and honour, I have to state that I have been staying at New Lambulane Imphal East Opposite Dimdailong near Nongpok thong at H/NO. 36 15/20 (Wangkhei Assembly constituency) Since 1975 and I was forced by the Porompat P/S to vacate my residential house on the midnight of 14 Sep. 20.

That due to prevailing ethnic violence and situation it come to light that my whole properties and belonging were found lost and some damaged by unknown miscreant, however the exact and time could not be ascertained but suspected to be in the month of between Dec - Jan 2024. I have assessed and calculated the lost and damaged of properties approximately to an amount of Rs 35,00,000 (Thirty five lakhs) only.

In this regard I would request your good office to look into the matter and do the needful for which I shall ever remain thankful to you Sir.
