





I have the honour to report that due to communal violence in between Kukis and Meiteis communities some unknown miscreants suspected to be Meitei community Arambai Tenggol, Meitei Leepun wearing Police and Commando uniforms forcefully attacked my residential Quarters located at office of the Directorate of Census Operation, Manipur, Quarters No. 1/III, PO & PS- Porompat, Imphal East District during the month of December, 2023.

As a result, they destroyed and looted all my valuable household properties including some important documents. The lost properties are approximately worth as Rs. 19,99,000/- only. Due to displace of all my family, I could not report in time.

I, therefore, humbly request you to kindly take up necessary legal action as per law of the land.
