



I beg to state that, I the undersigned aged about 84 years owned a pucca house at 2<sup>nd</sup> Street New Lambulane also known as New Checkon under 15- Wangkhei Assembly Constituency.

That, my daughter by the name Ngaijachong aged about 45 years and her family resides there Following 3<sup>rd</sup> May, 2023 violence in Imphal valley, they all were evacuated from Imphal leaving behind the house and all household items. Till 3<sup>rd</sup> of January, 2024 source informed that it was still safe. However, from a reliable telephonic source received on the 8<sup>th</sup> of January, 2024 some miscreants have all vandalized and looted all household items worth 8 lakhs. The incidents is suspected to have occurred on the 6<sup>th</sup> January 2024.

**Following are details of items looted :**

1. Sofa Set : 1 (one) nos.
  2. Jewellery : 1(one) gold chain
  3. Electrical appliance : a) Refrigerators  
b) Washing Machine  
c) Computer Set  
d) Smart TV-1 (one) nos.
  4. Steel Almirah : 2(two) nos.
  5. Mattress : 3 (three) nos.
  6. Cooking gas with 2 cylinder
  7. Clothings including blankets
