



Subject : Request for register FIR against the damage of my property at my residence  
New Lambulane, Imphal East.

Sir,

I have the honour to state that, I am a resident of New Lambulane, New Checkon Imphal Ea District, Manipur, That, On 3/05/2023 due to sudden broke out of communal conflict in Manipu Fearing lost of live self alongwith my family abandoned our house and fled to a nearby safe location : 1<sup>st</sup> BN. Manipur Rifles and evacuated to Kangpokpi District, Manipur.

Further, it is learnt from reliable source that, in between 4/5/2023 to 10/05/2023 some unknow miscreants have completely vandalised my house and looted all the valuable and moveable propertie:

The list of properties destroyed or loss are mentioned in the **Annexure (enclosed)**.

The Approximate value of lost properties including the land valuation is calculated at about R 3,47,95,000/- (Three crore forty seven lakhs and ninety five thousand) only as per own assessment.

Due to lack of legal knowledge I could not report to the concern authority in time.

It is, therefore, requested to kindly register a case and take necessary legal action against the culprits according to law.
