Sir,


I have the honour to report that, today i.e. 15/08/2023 at bout 6:15 pm a team of Sagolmang Police Station led by myself along with the accused person namely Moirangthem Milan Singh (29) years s/o. late Moirangthem Chaoba Singh of Haraorou Mayai Leikai and a joint teams of Imphal East Police (including Imphal East CDO teams) led by Shri Ksh. Shivakanta Singh, IPS, Superintendent of Police, Imphal East have left PS for taking safe custody of the accused person at Porompat Police Station in connection with Ref. FIR No. 692(8) 2023 SMG-PS U/S- 25(1-C) Arms Act. While reaching near Sambei Awang Leikai, Imphal East District some unruly mob numbering about 350 Men & Women blocked the road and started stone pelting against us and also tried to take down the accused person at around 6:30 pm same day. Dispite of giving 10 minutes to disperse the mob, they did n't disperse themselves. In that, having no option to disperse it , the police team fire some Teargas Shell and dispersed the mob.


It is therefore request to kindly taken up legal action against the unknown culprits.
