Whereby, I am a permanent resident of Thombol P.S Sagolmana District Kangpolyn 2.That,on 13 June 2023 at 9 AM/PM, a huge contingent of armed Radical Meeitei/Meitei Mobs, Arambai Tengol and Meeitei Leepun along with State Forces like Manipur Police Commando and Indian Reserve Battalion (IRB)attacked our village, and in the process looted/vandalized/burnt my house/properties. 3. That, the above said Criminals with their inhumane activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth lakhs estimated to be Rs 4. Fortunately, me and my family narrowly escaped from these Criminals who even tried to kill us.
