Subject : Report.

Sir,

I have the honour to state that, on 5-05-2023 at around 03:45 am some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) in large numbers carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, deliberately attacked our village C. Zoulen, under Saikul Sub-Division Kangpokpi District, Manipur about 24 km South East from Saikul-PS from the adjoining hill ranges nearby our village, by firing several rounds of live bullet upon us. Due to which my son namely, Mr. Letminlal Kipgen (21) yrs who is one of the village volunteers, have sustained bullet injuries on his person.

He was immediately evacuated for CHC Saikul to get him first aid and luckily he survived from his injuries.

Moreover, Due to lack of legal knowledge and heavy burden upon my family due to the ongoing communal conflict, I could not report the incident timely to the concern Authority.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
