



Subject : Complain Report regarding mental trauma and loss of properties.

Sir,

I, Hengoulen Misao S/o Saopu Misao would like to submit a complaint regarding an incident that took place in at my residence in House No. 199, New Lambulane, 1st Street, Imphal Municipal Council, Imphal East, Manipur. On 07.05.2023, we left our residence at New Lambulane and moved to IGAR (Army Camp) and later moved to Kangpokpi District on 07.05.2023 we left Imphal as no Kuki settlement in Imphal Valley was safe. Fearing for our lives, I along with my family members took few clothes and some important documents such as educational mark-sheets & certificates and fled to Kangpokpi Ward No. 6 at my relatives place for shelter with the help of the Indian Army.

Recently on 7th of January, 2024 I have learnt that, all my belongings in the above mentioned address have been looted completely.

It is duly submitted to you that due to this incident my family and I lost important original documents and property worth approximately Rs. 40,00,000/- (Forty Lacs only) along with the immovable property mentioned above. Due to this incident I also suffered from mental agony and stress. In light of the above-mentioned series of incidents, I request your good office to kindly register an FIR in interest of justice.
