



Sir,

I the under signed have the honour to state that, today i.e. 30/10/2023, search operations have been conducted in the locations namely Sanjenlok, Yangdoupokpi, Sanjenlok hill top (Mark), Eshingthembi hill tops, Wakan Hill Range and surrounding areas by a combined team consisting of district police Imphal East (SDPO LLI, DSP CDO, OC CDO IE and OC Sagolmang PS), 18th AR, 16th AR, 22nd AR, 6th IRB and 4th BN G coy CRPF led by Additional SP(Ops)/IE under the command of SP/IE from 7.00 am to 3.00 pm. The search ops have been supervised by IGP Zone-1 and DIG Range-1

In the search operation, the combined teams were divided and conducted simultaneous, multiple combing operations in the said areas, dismantled a total of 6 bunkers (4 bunkers built on Sanjenlok Hilltop, "MARK" bunkers and 2 bunkers built on esingthembi hilltop) and the following arms and ammunitions /articles which have been concealed by unknown miscreants are found at Yangthoupokpi Hillock during the ops-

- 1). 1(one) no. of .22 Rifle with empty Magazine bearing body No.A0736 Butt no.8
- 2). 2(two) no. Of 9MM Local-made Pistol with empty Magazines
- 3). 1(one) no. Country made Pistol
- 4). 1 (one) no. of SMG carbine with empty magazine
- 5). 2(two) no. of INSAS empty Magazine
- 6). 1(one) no. of empty SLR Magazine
- 7). 1(one) no. of Muzzle loading Rifle
- 8). 34(thirty four) nos. of AK47 empty Shell
- 9). 6(six) nos. GREN 80WP MK-1 with 6(six) Detonators
- 10). 1(one) no. of Broken Butt of DBBL
- 11). 14(fourteen) nos. of 36 HE Grenade
- 12). 15(fifteen)nos. of Tube Launchers
- 13). 10(Ten)nos. of Arming Ring
- 14). 6(six) nos. of HD cartridges.
- 15). 1 (one) no. of motar shell.

The articles are seized by preparing formal seizure Memo on the same day at about 1:10 pm.

The seized items are handed over to Sagolmang PS for further legal formalities.
