Sir,

With due respect, I, the undersigned have the honour to report that today i.e. 25/11/2023, conducted Cordon and Search Operation (CASO) by a combined team comprising of CDO Imphal East, Sagolmang PS, 22 AR and 18 AR led by Shri Kh. Herojit Singh, MPS, Addl. SP Operation Imphal East assisted by Sub. Zakaria and SI. Uttam Singh, under the supervision of Shri. Dr. S Ibomecha Singh, MPS, Superintendent of Police, Imphal East in areas namely P. Geljang Village, Kangpokpi District under the jurisdiction of Sagolmang Police Station and Tiger Camp under Sagolmang PS in Imphal East District from 6:30 am to 09: 00 am.

In the search operation, the combined team cordoned and searched about 30 suspected houses in Tiger Camp village and the occupants were verified but no one was detained and seized or recovered any incriminating articles. Further, while conducting foot-patrolling and intense search in and around P. Geljang Village foothill areas, the combined team detected a gunny bag which was found concealed under bushes at the road side of P. Geljang Village. On checking the said gunny bag, the following incriminating items were found.

- (1) One Carbine Rifle mark as 30141 with empty Mag.
- (2) One SLR regd. No. 16028921 with one empty Mag. and Butt No. 142 ADM.
Broken hand Grip.
- (3) One 9mm pistol country made with one empty mag.
- (4) One 9mm pistol country made with one empty mag.
- (5) One .22 Pistol country made with one empty mag.
- (6) One local made Grenade.
- (7) Two 36 HE hand Grenade without detonator.
- (8) One Chinese Hand Grenade.
- (9) One piece of detonator.
- (10) 16 pieces of broken PEK.
- (11) Two bottles full of suspected charge with attached cordex wire each.
- (12) One gunny bag.

So, the above listed items were seized and recovered from the spot i.e at the road side of P. Geljang village at 08:10am by observing necessary formalities in presence of witnesses.

Therefore, the following seized incriminating items i.e. arms and ammunitions are being handed over to you for taking up further necessary legal action.
