Sir.

I the under signed have the honour to state that, I am the resident of SaduYengkhumanMakhaLeikai and my house is neighbouring with Nepali community. On 03/5/2023 at about 8:30 pm, while I along with my family members living inside our house some unknown armed persons suspected to be Kuki militants with the support of the surrounding Kuki villagers numbering about 1000 attacked by opened fired at our village SaduYengkhuman, Imphal East District, Manipur and started damaged properties and burning houses. However, we somehow managed to escape from our village and took shelter at RSS office relief Camp Haraorou. Later, on 05/10/2023 we shifted to Sawombung Relief camp Imphal East, Manipur. On 17/11/2023 at about 2.00pm while I was staying at said relief camp an information was received from my neighbouring Shri Prakash Bista (57) years that, on the same day morning at about 8.00 am some unknown armed Kuki militants damaged my house after looting all the household properties.

The undernoted my belonging properties were looted /damaged in the incident.

- 1. One House (Kutch) worth about-Rs. 600000/- (Six lakhs) only.
- 2. Granary worth about- Rs. 100000/-
- 3. Paddy grain 40 bags. worth about Rs. 40000/-
- 4. Furniture items worth about Rs. 400000/- (Four lakhs) only.
- 5. Electronic items worth about -Rs. 150000/- (One lakh fifty thousand) only.
- 6. Traditional clothes items worth about -Rs. 250000/- (Two lakh fifty thousand) only.
- 7. One Rice mill worth about -Rs. 200000/-

I therefore request to kindly taken up legal action against the involved unknown armed Kuki militants.

I could not report well in time due to lack of legal knowledge
