Subject: Report.

Sir,

I have the honour to inform you that due to sudden outbreak of violence at Imphal on 3rd May, 2023, I along with family member suddenly left our residential house located at New Lambulane 1st Street, PO/PS-Porompat, Imphal East District, Manipur on 4th May, 2023 at around 7:30 pm for saving our life from the attack of the Meitei miscreants. So, our residential house along with all household properties were suddenly left behind unattended.

That, I came to learnt that my residential house was intruded by some valley based organization suspected to be volunteers of Arambai Tenggol, kangleipak Kanba Lup (KKL) and Meitei Leepun and looted all our properties including clothing, furniture, kitchen items, electronic gadgets, gold ornaments, important documents etc. The exact date and time of the incident could not be ascertained, however it is suspected to be happened in the *last week of November, 2023*. The approximate lost properties worth Rs. 1.5 crores only. It is therefore requested to take up a necessary legal action according to law.
