

Today i.e 01/01/2024 at 05:50 pm, received an information that on the same day at around 05:45 pm, one unknown vehicle Bearing Registration No. not known driven by unknown driver coming from Wangjing side towards Heirok Part-II Maning Leikai dash to one four wheeler i10 four wheeler car bearing registration No. MN1G 1872 driven by unknown driver which was coming from opposite direction at Heirok Part-II Maning Leikai near Heirok Welcome gate along Heirok Part-II IVR due to rash or negligent driving on the part of the unknown driver of unknown vehicle and the unknown vehicle fled away there after the commission of crime. As a result of which the unknown driver of four wheeler i10 car bearing registration No. MN1G 1872 and one occupant received injuries on their persons and evacuated them to Hospital for medical treatment. The Four wheeler i10 car bearing registration No. MN1G 1872 was also partly damaged.
