Subject : Report.

Sir,

With due regards, I am to report that today i.e. 23/01/2024 at about 10.15 am 07 (seven) armed miscreants who identified themselves to be members of banned outfit KCP Apunba Langamba Group, coming in two vehicles (one Gypsy and one Maruti Swift Car, registration nos. not known) broke into the house of my uncle namely Khangembam Priyojit Singh aged about 55 years, S/o Late Kh. Mani Singh of Tentha Khongbal Mayai Leikai, P.O.- Wangjing, P.S-Khongjom, Dist.- Thoubal, Manipur, (Nominee of ZP Wangjing Tentha), which was kept under proper lock and key. Then the armed miscreants started to break the front door of my uncle without giving any reason and get inside the house. As such the miscreants dismantled and destroyed many household materials like doors, glasses of windows, and also materials found inside the bedroom, kitchen and living room (almirah, godrej, bedroom furniture, refrigerator, table, chairs). While the unknown armed miscreants were busy destroying the materials inside the house, one woman namely Waikhom Gambhini Devi, aged about 67 years, W/o Late W. Lukhoi Singh came to intervened and asked them to stop, however the armed miscreants refused and threatened the woman with dire consequences if given hindrances. After destruction the armed miscreants left the place. When the incident took place, my uncle along with his family members were in Delhi for medical checkup of my uncle.

Further my uncle told me that the monetary demands of Rs. 20,00,000/- (rupees twenty lakh) put up by the banned outfit KCP Apunba Langamba Group to him earlier, had not been delivered till date and had been threatened since some days back.

The approximate value of the damaged properties of my uncle's house is about Rs. 2,00,000/- (two lakh).

It is therefore requested to kindly take up necessary legal action against the culprits as per admissible law.
