





Today i.e. 13/01/2024 at 8.20 pm, received an information that on the same day at around 8.15 pm, one Tata DI bearing regd. No. MN04 - 1622 driven by unknown driver which was coming from Thoubal side and proceeding towards Yairipok side collided with one Maruti car bearing regd. No. MN01X - 3356 driven by unknown driver which was coming from opposite direction along Thoubal Yairipok road near the new gate of Ananda Purna Higher Secondary School, Thoubal Tomjing Makhong due to rash or negligent driving on the part of the both unknown drivers. As a result of which the unknown driver and two occupants of the Maruti car got injuries on their persons and evacuated to hospital for medical treatment. Both the vehicles were partly damaged.

Hence, a suo-motu case under FIR No.05(01)2024 TBL-PS U/s 279/338/427 IPC has been registered for investigation.
