



Sir,

I have the honour to state that on 31/12/2023 at about 12.15 Am while I along with some Labours were sleeping inside the khola at Durgapur Village for construction of J.T road (P.W.D).Some gunshot sound numbering about 4/5 fired by the unknown persons heard. Immediately we went out from the khola and found that the electric blub which was installed near the khola was broken as hit by the bullets. However the unknown persons had already fled away from there. The act of the unknown persons is attempting to the life of the labours leaving in the khola.

It, is therefore, requested kindly to take up necessary legal action against the unknown miscreants.
