Sir,

I, the undersigned have the honour to report that on 12/12/2023, (i) Ajmal Nisa, Imran Ahmed, Islaur Rahman, Abdul Barik and Md. Abul Kalam who are the caretaker councillors of ward no. 3, 1, 4, 6 and 7 respectively lodged a complaint report to OC/LIL-PS stating that the accused persons namely (1) Md. Madani Ali S/O (L) Md. Yushub Ali resident of Lilong Turel Ahanbi, Darul Uloom Makha (2) Mrs. Ibemcha W/O Md. Madani Ali resident of Lilong Turel Ahanbi, Darul Uloom Makha and (3) Md. Abdul Helim S/O (L) Md. Umed Ali resident of Lilong Haoreibi Lou Manga committed the offences of forgery, impersonation with conspiracy and common intention by doing the following activities. They manufactured and fabricated a proceeding of meeting of caretaker councillors of the Lilong (Thoubal) Municipal Council dated 28.10.2022 and submitted an application dated 18.07.2023 to the commissioner, MAHUD, Government of Manipur for appointment of the accused no. 2 to the caretaker chairperson of the council. The signature appearing in the application is also a forged one. The signatures of 8 (Eight) caretaker councillors enclosed in the resolution dated 28.10.2022 are manufactured from the previous records and signature obtained for other purposes. There was no meeting of the caretaker councillors held on 28.10.2022.

In view of the above facts, the accused persons committed offences of forgery, manufacture of documents with common intention and they are liable to be punished. It is therefore requested that a criminal case be registered against them for investigation and inflicting punishment in public interest.

On receipt of the above complaint report, the OC/LIL-PS made G.D. Entry vide GD Entry No. 12/LIL-PS dated 12/12/2023 and endorsed to SI Md. Anwar Hussain for enquiry and further re-endorsed to me for further enquiry.

During the course of enquiry, examined the complainants minutely and they fully corroborated with the fact of OE lodged by them in the case. They further stated that there was no any resolution and meeting to appoint Mrs. Ibemcha as caretaker chairperson.

In the line of further course of enquiry, a requisition has been submitted to the Executive Officer, Lilong Municipal Council to furnish relevant document i.e. Notice Copy served to the Councillors of Lilong Municipal Council regarding meeting for appointment of Caretaker Chairperson. Accordingly the Executive Officer, Lilong (Thoubal) Municipal Council forwarded a letter informing to OC/LIL-PS that no record for holding a meeting on 28/10/2022 is available in the office record and since the 20<sup>th</sup> day of February, 2023 after he took the charge of Executive Officer of Lilong (Thoubal) Municipal Council, there was no meeting for appointment of caretaker chairperson till date.

From the enquiry conducted so far, it came to know that the meeting resolution was drafted by Md. Abdul Helim S/O (L) Md. Tomba of Lilong Haoreibi Lou Manga at his house in collusion with Md. Madani Ali and. Ibemcha W/O Md. Madani Ali.

From the findings in the enquiry, it is revealed that the accused persons mentioned in the complaint report namely (1) Md. Madani Ali S/O (L) Md. Yushub Ali resident of Lilong Turel Ahanbi, Darul Uloom Makha (2) Mrs. Ibemcha W/O Md. Madani Ali resident of Lilong Turel Ahanbi, Darul Uloom Makha and (3) Md. Abdul Helim S/O (L) Md. Umed Ali resident of Lilong Haoreibi Lou Manga have committed the offences of forgery, impersonation with criminal conspiracy.

It is therefore submitted the enquiry report for taking further necessary legal action against (1) Md. Madani Ali S/O (L) Md. Yushub Ali resident of Lilong Turel Ahanbi, Darul Uloom Makha (2) Mrs. Ibemcha W/O Md. Madani Ali resident of Lilong Turel Ahanbi, Darul Uloom Makha and (3) Md. Abdul Helim S/O (L) Md. Umed Ali resident of Lilong Haoreibi Lou Manga.
