Today, i.e. 17/01/2024 at about 07:10 pm a large number of unruly mob violently attacked at The District Police Head Quarter, Thoubal with an intention to snatch fire arms and destruction of Government properties where the district police and BSF personnel tried to disperse it by using minimum force such as Tears Smoke and stun shells etc. Several live rounds were continuously fired towards the police and BSF team as well as throwing of petrol bombs were seen. In that 3 (three) BSF personnel stationed at DHQ Thoubal of 42nd Battalion BSF, B-Coy received grievously injuries caused by fire arm and burnt injuries. Accordingly, they were evacuated to District Hospital Thoubal for medical treatment. Finally, the mob were dispersed at @ 11:00 pm.

Hence, a suo-motu case FIR No. 10(1)2024 TBL-PS U/s 147/148/149/307/326/353/384/511/427/436 IPC, 25(1-B) Arms Act, & 3 PDPP Act, 1984 has been registered for investigation.
