Today i.e. 05/01/2024 at 06.00 pmg Lanspil N. Suresh Singh, Officer-in-Charge, Khongjom Police Station) left Khongjom-PS-along with my escort party for patrolling along NH-102 Trans-Asian Highway towards Uningkhong Bridge which is the northern end of my police station jurisdiction. On the way I had received a telephonic call from C/No. 0915716-Ok. Megha Singh now posted at NAB, Manipur informing me that one Motor Bike (Royal Enfield) bearing registration No. MN01AN-0025 for a friend of his neighbouhood brother Ksh. Kiran of Sinjamei Kshetri Leikai has been stolen away from Singjamei Kshetri Leikai Land No. 4 near the gate of Kshtrimayum Roshan Singh toda. i.e. 05/01/2024 at about 05.30 pm. He requested me to have a look out for the said molor bike and to recover the same and to arrest the culprits if found. When I proceeded ahead and reached near Gobit Brick Field along NH No. 102, I saw two persons coming from the opposite direction with a motor bike pushing along the Highway. Being suspicious, I stopped and wanted to check the motor bike. On seeing me and my team, the two persons left the motor bike and ran away across the open paddy field. I and my team chased them and could arrest one out of the two persons. I inquired about the particulars of the person arrested and the person who escaped arrest.

He identified himself as one Md. Abdul Wahid aged about 32 years S/o Md. Abdul Manal of Lilong Ushoipokpi Tharaok, P.O & P.S. Lilong, Thoubal Dist., Manipur, and the particulars of the person escaped is one Yumkhaibam Mohsin aged about 25 years S/o Md. Nurjaman of Lilong Turel Ahanbi Awang Leikai. 02 (two) mobile phones - (i) OnePlus 10T 5G, and (ii)Nokia keypad phone were also found from the possession of Md. Abdul Wahid.

Fig has been brought to the place where the motor bike had been left by them. The registration number of the motor bike is found tallied with the number and particulars furnished by constable Ok. Megha Singh to me over phone. On further questioning about the motor bike, he disclosed that he and his friend namely Yumkhaibam Mohsin had stolen the motor bike from Singjamei Kshetrileikei by using master key which has been taken by the person who escaped arrest. Another mobile phone also found abandoned at the paddy field near Gobit Brick Field. Accordingly Md. Abdul Wahid aged about 32 years \$\frac{9}{9}\$ Md. Abdul Manal of Lilong Ushoipokpi was arrested at 06.45 pm and seized the Motor Bike (Royal Enfield) bearing registration No. MN01AN-0025 and two mobile phones along with 02 sim cards from his production at 06.50 pm by observing formalities. And another abandon mobile phone with 02 sim cards was also seized at 07.10 pm.

The person along with the seized items have been brought to Police Station and a case has been registered under FIR No. 01(01)2024 KJM-PS U, s- 379/34 IPC on suo-motu against (1) Md. Abdul Wahid aged about 32 years S/o Md. Abdul Manal of Lilong Ushoipokpi Thuraok, P.O & P.S. Lilong, Thoubal Dist., Manipur and (2) Yumkhaibam Mohsin aged about 25 years S/o Md. Nurjaman of Lilong Turel Ahanbi Awang Leikai, P.O & P.S. Lilong, Thoubal Dist., Manipur, for investigation.
