Hassan S/o. Md. Habibur of Lilong Tamyai while trying to intervene by the localities from kidnaping the said Md. Hassan. As a result of which, 3 (three) localities succumbed to their injuries at the spot and seven persons received injuries on their persons. The unknown arm miscreants fled away from the scene after committed the crime by leaving the Maruti Gypsies. Later, the Maruti Gypsies have been burned down by the localities.
