

Today i.e. on 01/01/2024 at 7.40 pm received a reliable information that on the same day at around 7.30 pm some unknown arm miscreants suspected to be valley based UGs who came in the Maruti Gypsies open fire to the localities of Lilong Tamyai and Chingjao along IVR Lilong Tamyai via Chingjao at near the residential gate of one Md. Hassan S/o. Md. Habibur of Lilong Tamyai while trying to intervene by the localities from kidnaping the said Md. Hassan. As a result of which, 3 (three) localities succumbed to their injuries at the spot and seven persons received injuries on their persons. The unknown arm miscreants fled away from the scene after committed the crime by leaving the Maruti Gypsies. Later, the Maruti Gypsies have been burned down by the localities.

Hence registered a suo-motto case under FIR No. 01(01)2024 LIL-PS u/s 302/435/511/34 IPC, 20 UA (P) A. Act & 25(1-C) Arms Act for investigation.
