Sub: - LODGING OF FIR

It is to inform you that, E coy Ex-15 Bn BSF deployed under Adhoc NB -VIII for L & O duty at 3rd camp Thoubal, Manipur.

On 17th Jan' 2024 at about 1800 hrs, a mob of approx 500-600 civil people gathered at gates of 3rd IRB Bn and forcefully entered in campus by breaking the gate no. 01 for the purpose looting/snatching arms and ammunition from IRB Kote/armouries. Few of them were in black uniform and fired tear smoke shell towards BSF troops. Initially BSF troops tried to stop them by using minimum force, but the mob became more aggressive and demanding weapon/arms and also tried to capture the armouries/kote of 3rd IRB. Seeing this, BSF troops fired non-lethal munition to disperse the crowd.

As the situation was going very hostile BSF troops fired non-lethal munition and 5.56 mm INSAS for self defence and to disperse the crowd. While mob was dispersed at about 2045 hrs. After this incidents when checked, no loss/damage of man & material of BSF found.
