Subject : Report.

Sir,

With due regards, I beg to state that today i.e. 03/02/2024 at about 05:30 am received a reliable information that some unknown miscreants have stored some arms, ammunitions and explosives at the bush of Phainom village.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Somrei, 33 AR led by Shri Okramcha Wangkhomba, MPS, Addl. SP(Ops)/TBL assisted by OC/CDO-TBL along with a team of NSK-PS including women personnel in all under his supervision i.e. Addl. SP(Ops)/TBL have rushed to the spot immediately and launched a massive operation at 06:30 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 01 (one) No. of .303 Rifle bearing registration Nil, (2) 01 (one) No. of DBBL, (3) 02 (two) Nos. of 36 HE Hand Grenade (can be used as explosive), (4) 01 (one) No. of 51 mm ILLG, (5) 02 (two) Nos. of WP GREN No. 80 MK-1, (6) 01 No. of Handheld Chinese Walkie Talkie, (7) 01 (one) No. of Tear Smoke Shell Soft Nose, (8) 01 (one) No. of Cartridge 38 mm Anti-Riot with Rubber Bullet, (9) 01 (one) No. of 5.56 mm INSAS Rifle magazine, (10) 01(one) No. of 5.56 INSAS LMG magazine, (11) 02(two) Nos. of BP Jacket Harness, (12) 05(five) Nos. of 7.62 mm ammunitions and (13) 03(three) Nos. of Bore Cartridges have been seized from the spot at 07:30 am. The massive searched Operation was conducted from 06:30 am and continue till 08:15 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
