SUB: FIRST INFORMAMATION REPORT

It is to inform you that on 17th Jan' 2024 at about 1650 hrs mob of approx 150 people gathered in front of SP office main gate and talked with SP Thoubal about Moreh firing incident and later on they further moved towards DC Office Thoubal at about 171700 hrs. Again at about 1915 hrs mob gathered in front of SP office Thoubal. Initially, BSF troops tried to stop them by doing conversation but later on at about 2030 hrs mob started throwing petrol bomb and the situation became hostile. After such incident No.860027982 SI Sinu Ram Ichagutu (PL Comdr) ordered the troops to fire in the air in order to disperse the mob. By getting such order No.110502683 CT Manpreet Singh fired 10 Rds of 5.56 mm CTN ball (lot No.056 KF 09/19) by INSAS Rifle butt no.124 and body No.16537123 in the air. At about 2040 hrs mob forcefully tried to enter inside the gate and in order to disperse the mob BSF troops fired in the air by small arms due to which mob ran away from SP office. At about 2100 hrs Arambai Tenggol/miscreants fired upon BSF troops from roof top & adjacent area inside of District Court Thoubal due to which at about 2120 hrs No.124523629 CT Gaurav Kumar sustain injury below chin by splinter and No.897225614 ASI Subran Singh sustain bullet injury on his left side of Chest and right hand. After that our troops immediately retaliated and evacuate the aforesaid injured personnel. Again at about 2135 hrs No.892435289 ASI Ramji sustain bullet injury on right side of rib cage and was evacuated by troops by doing retaliation.

Then after at about 2205 hrs all aforesaid 03 injured personnel along with No. 935040757 HC Rana Partap Singh (Attender) shifted to district hospital Thoubal by BP Vehicle of SP Thoubal where doctor checked and further referred all 03 injured personnel to Raj Medicity Hospital Imphal and they are under treatment. At about 2230 hrs mob dispersed from surrounding area of SP Office Thoubal and the situation came under control.

During the entire firing incident troops deployed at SP office specially Platoon Commander (SI Sinu Ram Ichagutu) and injured personnel i.e ASI Ramji, ASI Subran Singh and CT Guarav Kumar did gallant action who were in the front and without caring for their personal lives stood against volley of fire coming from 2-3 directions as well as facing constant hurling of petrol bomb could stop looting arms/ammunitions of SP Office Kote.
