Subject : Report.

Sir,

With due regards, I beg to state that today i.e. 27/12/2023 at about 04:00 PM received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Kwarok Maring for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Thoubal, 33 AR and 62 Bn. BSF led by Addl. SP(Ops)/TBL assisted by OC/CDO-TBL under the supervision of Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 04:26 PM by using metal detectors. On searching and found the undernoted articles i.e. (1) 01 (one) No. of Country Made Pistol along with magazine, (2) 1 (one) No. of Country Made Carbine along with 1 (one) magazine, (3) 01 (one) No. of Country Made AK-47 without magazine, (4) 03 (three) Nos. of Bayonets of AK-47, (5) 2 (two) Nos. of Bayonets of 5.56 mm INSAS Rifle, (6) 01 No. of Chinese Walkie Talkie, (7) 03 (three) Nos. of Stun Shell (Normal), (8) 03 (three) Nos. of 36 HE Hand Grenade (can be use as explosive) and (9) 02 (two) Nos. of 9mm magazine from the spot at 06:00 PM. And further seized the aforesaid articles at 06:26 PM of the same day i.e. 27/12/2023 by observing necessary formalities. The massive searched Operation was conducted from 04:26 PM to 06:30 PM on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
