## Subject: LODGING OF FIR AGAINST MEIRA PAIBIS

Sir,

- 1. Based on HUMINT received ON 23 Noy 2023 approx 11-12 Arambai Tenggol cadres were likely to vis sensitive areas of Tumukhong Vill on the morning of 24 Nov 2023. An Op by Army was planned to block all routes of Ingress and Egress towards Tumukhong and number of the Rd Blocks were enhanced for svl. The operation was launched on 24 Nov. at 0600 hrs where in at 0915 hrs, the Surprise MVČP at Nongren stopped nine Arambai Tenggols, travelling in a Maruti Gypsy and Bolero without any wpns. Both vehicles moving in from Lamlai Junction towards Tumukhong tried to evade the road blocks, however, were blocked by the Army pers.
- 2. At approx 0930 hrs, the said column was surrounded by riotous mob comprising of aggressively agitating ladies identifying themselves as Meira Paibis who pushed the Army Pers way from the apprehended individuals and their vehicles thereby wrongfully confining the personnel and preventing the Army column to carry out the operation. The Army column requested the Meira Paibis not to obstruct the Army personnels from carrying out their bonafide Military duty, however they refused to do so and tried to assault and cause hurt to Army personnels including attempt to snatch the personal weapons of the Army personnel. However, when a team from Lamlai PS arrived on location, the Meira Paibis allowed them to interact with the apprehended individuals and escort them to Lamlai PS.
- 3. At Lamlai PS, while the verification of the apprehended pers was underway, a riotous situation was created by the Meira Paibis outside the Police Stn to prevent the screening of suspected miscreants by the Army coin. The Meira Paibis surrounded the Security Forces physically, assaulted them & tried to snatch their weapons thereby, attempting to disrupt the entire situation. The mob also blocked the National Highway and hindered the mov of Army pers and vehs. A few Meira Paibis also attempted to damage the Army vehs and tried to break the window panes and windshield of the government property.
- 4. All the photographic evidences of the incident spot are enclosed along with the certificate under Section 668 of the Indian Evidence Act, 1872. The said rioters may immediately be identified and arrested to prevent them from giving effect to their criminal intent and conspiracy.
- 5 Further, it is requested that FIR against unknown/ unidentified rioting Meira Paibis other rioters may be lodged for the following offences \*
  - (a) Obstructing Public Servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to the aforementioned provn incl Sec 353, 503, 504, 505 and 506 of the IPC.
  - (b) Obstructing the Public Servants in apprehending the miscreants and unlawfully resisting their arrest contrary to IPC 186.

- (c) Criminal Intimidation, Assault and Criminal Force against Public Servants discharging public duty in Aid to Civil Authorities contrary to Sec 34, 120, 350, 353 and 332 of the IPC.
- (d) Instigating and abetting the Unlawful Assembly of rioting Meira Paibis and locals to obstruct the Army in performance of their lawful duty on 24 Nov 2023 contrary to Sec 34, 120. 353, 505 and 147 of the IPC.
- (e) Intentionally attempting to snatch weapons from Indian Army personnel who were performing bonafide Military duty in Aid to Civil Authorities contrary to Sec 201, 223, 224 and 225 of the IPC.
- (f) Rioting while being armed with a deadly weapon or with anything which if used as a weapon is likely to cause death contrary to Sec 147 of the IPC.
- 6. The Hon'ble Supreme Court in Lalita Kumari Vs Govt of UP (MANU/ SC/ 1166/ 2013) has held "It is mandatory to file the FIR u/s 154 of the Code if the information discloses the commission of a cognizable crime and no preliminary investigation is permissible in such a case". In deference to the Hon'ble SC ruling, you are requested to register a First Information Report against the above mentioned persons.
- A copy of the FIR and Police report on completion of investigation may please be provided to this office for our records in accordance with Section 173 (2) (ii) of the Criminal Procedure Code, 1973.
