Officer-in-Charge Lilong Police Station Thoubal District, Manipur Today i.e. on 01/01/2024 at 8.10 pm some unknown persons numbering about 200/300 persons including female came and assembled and formed an unruly mob in front of PS in connection with the killing and sustain bullet injuries to innocent people by unknown arms miscreants suspected to be valley base UGs at Lilong Chingjao near the residential gate of Md. Hassan on 01/01/2024 at about 7.30 pm. The police teams on duty at the gate intervened the unruly mob however, the said unruly mob became violent and started pelting stone toward the police personnel on duty despite giving warning to them. The unruly mob stormed inside PS campus forcefully and caused damaged some vehicle parked inside the PS campus including the Gypsy allotted to Addl. SP (Ops), Thoubal and OC/Lilong PS. The mob was dispersed by using minimum force including lathi charge and tear smoke shall at about 8.30 pm.

Hence registered a suo-motto case under FIR No. 02(01)2024 LIL-PS U/S 147/148/149/151/353/427 IPC & 3-PDPP Act has been registered for investigation.
