Today i.e 28/12/2023 at 8.50 pm received an information that on the same day at around 8.40 pm, one Hyundai i20 car bearing registration No.MN03A-2846 driven by unknown driver which was coming from Wangjing side and proceeding towards Thoubal side collided with one Maruti Alto car bearing registration No. DL2CAN-3104 driven by unknown driver which was crossing on the western side of the Khangabok village along NH-102 at Khangabok opposite, Khangabok Higher Secondary School due to rash & negligent driving on the part of the both drivers. As a result of which 5(five) persons got injuries on their persons including drivers of the both vehicles and evacuated to hospital for medical treatment. Both the vehicles were also badly damaged.

Hence, a suo-motu case under FIR No. 210(12)2023 TBL-PS U/s 279/338/427 IPC has been registered for investigation.
