Today i.e. 19/12/2023 at about 10:15 am when self and Police party, District Police, Thoubal including women police led by SDPO, Yairipok were on duty near Yairipok Bamon leikai Canal Mapal received an information that some unknown men and women numbering about 200/300 who claimed to be relatives and neighbours of a deceased person namely Oinam Gandhi (32) S/o O. Mohon of Bengi Mayai Leikai at Leingangpokpi, District, Jiribam, gathered at the house of the alleged killer namely Loitam Arunta S/o (L) L. Kesho of Yairipok Bamol leikai. The homicide allegedly took place at Jiribam District. They started to damage the house of the alleged killer. Immediately self and Police party led by SDPO, Yairipok rushed to the house of Loitam Arunta and prevented immediately by the Executive Magistrate, Thoubal available at the spot and under his direction, dispersed the mob by the District Police, Thoubal. However, some portions of the house of Loitam Arunta were damaged by the mob.

Hence a suo motto case under FIR No. 33(12)2023 YPK-PS u/s 147/148/149/448/427 IPC has been registered for investigation.
