Today i.e. 13/01/2024 at 04:55 pm received an information that on the same day at about 04:45 pm one scooter Ntoru coming from Heitroipokpi side towards Yairipok bazar side ridden by unknown rider collided with one Honda Activa coming from same direction ridden by unknown rider at Yairipok Bamon Leikai near Mangya Lampak along Yairipok Chandrakhong road due to rash or negligence driving on the part of unknown riders of the both vehicles.
