Today i.e. 17/12/2023 at around 12.35 pm received an information that on the same day at around 12.30 pm one Honda Activa blue in colour bearing Registration No. nil ridden by unknown rider dashed on the rear right side of one i10 car light blue in colour bearing Registration No. MN01AX-0922 driven by unknown driver plying from same direction i.e. Khongjom Bazar side towards Wangjing side along NH No. 102 at near the junction of Khebaching, Shivanagar due to rash and negligent driving on the part of two vehicles. As a result of which the unknown rider and one unknown pillion rider of Honda Activa received injuries on their persons and evacuated to Hospital for medical treatment. In that the Honda Activa was badly damaged and i10 car was partly damage.
