Sir,

I, the undersigned have the honour to report that on 14/12/2023 at about 06.30 pm, when I was going with my Alto car bearing registration No. AS-02-AD-4950, silky silver in colour from Sangaiyumpham to Sora, some unknown persons stopped me at near Samaram Pukhri Achouba. Immediately the unknown persons started assault to me without any reason and dragged me out from the vehicle. I was beaten up brutally at there and then took away my Alto car, mobile phone " Redmi 12" having sim card No. 9615633759 and some wearing clothes by the unknown miscreant taking the advantage of darkness. I got serious injury on back abdomen and thigh. I could not report the matter in time due to medical treatment.

It is therefore requested to kindly take up necessary legal action against the miscreant as well as to recover the lost Alto car, mobile phone and other belonging at the earliest.
