Subject :- Report

Sir,

I, the undersigned have the honour to report that on 12/1/2024 at about 11:30 pm, received an information from a reliable source that some illegal contraband drugs/substances would be transported through the IVR of Lilong Haoreibi Makha Leikai by unknown drug peddlers in the intervening night of 12/1/2024 and 13/1/2024. The source report has been reduced in writing and forwarded a copy to Sr. SP/TBL. Without any delay, self along with police team and Shri W. Ibocha Singh, MPS, SDPO/Thoubal and his team along with members of YPC (Young Progressive Club), Lilong Haoreibi Makha Leikai under command of Addl. SP(L/O)TBL and under the supervision of Sr. SP/Thoubal rushed at the said place and conducted frisking & checking of all passerby at near YPC Office along IVR of Lilong Haoreibi Makha Leikai. During frisking & checking, on 13/1/2024 at about 1:15 am, one unknown person was coming from Makha Leikai Konjil towards Makha Leikai Salam Manung side in a suspicious manner. On his suspicious manner, he was detained for verification. On verification, he identified himself as Md. Manjoor Alam @ Bokhan (30) S/O Late Md. Yakub Ali of Lilong Haoreibi Makha Leikai Lairaba Khong. I informed him that I have the suspicion that he has possessed some contraband drug and want to search/check his body. I gave him option whether he would like to be searched his body in presence of any Gazetted officer or Civil witnesses or Executive Magistrate. In that, he opted to be searched his body in presence of civil witnesses. I requested two civil witnesses available there and they also accepted to be witnesses during the search/checking the body of the detainee Md. Manjoor Alam (30). The option statements were reduced in writing in presence of the civil witnesses and Shri W. Ibocha Singh, MPS, SDPO/Thoubal. I and police team in presence of the civil witnesses and Shri W. Ibocha Singh, MPS, SDPO/Thoubal searched his body and on searching/checking his body, one soap case green in colour containing brown substance wrapped in a transparent polythene suspected to be Heroin powder was found concealed under his sweat shirt. On weighing the suspected Heroin powder by using weighing machine, it is found to be weighted 13 grams including the weight of transparent plastic polythene. The soap case containing suspected Heroin powder has been packed in a yellow envelope & marked as "A". Accordingly on 13/1/2024 at 1:30 am, seized the soap case containing suspected Heroin powder weighing 13 grams from the possession of Md. Manjoor Alam @ Bokhan (30) S/O Late Md. Yakub Ali of Lilong Haoreibi Makha Leikai Lairaba Khong by preparing a formal seizure memo in presence of the civil witnesses. Accordingly Md. Manjoor Alam @ Bokhan (30) S/O Late Md. Yakub Ali of Lilong Haoreibi Makha Leikai Lairaba Khong was arrested at 1:35 am by preparing a formal arrest memo at the spot for being a drug peddler.

On further frisking and checking, at about 1:40 am of 13/1/2024 another unknown person was also found coming towards us in a suspicious manner. When we stopped him, he tried to flee away. Immediately the police team nabbed him and on verification, he identified himself as Md. Musha Khalin (36) S/O Md. Rahimuddin of Lilong Haoreibi Makha Leikai. As there is suspicion that there will be some contraband items on his possession, I gave him option whether he would like to be searched his body in presence of any Gazetted officer or Civil witnesses or Executive Magistrate. In that, he opted that he desired to be searched his body in presence of civil witnesses. I requested the two civil witnesses and they also accepted to be witnesses during the search/checking the body of the detainee Md. Musha Khalin (36). The option statements were reduced in writing in presence of the civil witnesses and Shri W. Ibocha Singh, MPS, SDPO/Thoubal.

I and police team in presence of the civil witnesses and Shri W. Ibocha Singh, MPS, SDPO/Thoubal searched his body and on searching/checking his body, one transparent plastic polythene containing 91 nos. of loose capsules blue in colour marked as "PROXIWEL SPAS" suspected to be SP capsules was found concealing in the inner pocket of his jacket shirt and 47 grams was found on weighing by using weighing machine and the same was packed in a yellow envelope & marked as "B". Accordingly at 1:55 am of 13/1/2024, the transparent green transparent plastic polythene containing 91 nos. of suspected SP capsules was seized from the possession of Md. Musha Khalin (36) S/O Md. Rahimuddin of Lilong Haoreibi Makha Leikai by preparing a formal seizure memo in presence of the civil witnesses and Shri W. Ibocha Singh, MPS, SDPO/Thoubal. And at 2:00 am of 13/1/2024, the accused person Md. Musha Khalin (36) S/O Md. Rahimuddin of Lilong Haoreibi Makha Leikai was arrested at the spot by preparing a formal arrest memo for being a drug peddler.

It is therefore, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
